How to Complete a Consumer Rebate Claim: 1. A participating and eligible dealer installs the equipment shown on the Rebate Program Eligible Equipment Chart 2. Within 60 days of installation, the end-user must complete the Consumer Rebate Claim Form via the link [www.ductedsystemsincincentives.com](http://www.ductedsystemsincincentives.com) by selecting the applicable user category and provide the following information: a. Personal Information Note: Claims are automatically submitted for standard warranty registration. Ensure the owner name listed on the claim is the legal name associated with the home ownership. b. Product Information including serial number and installation date Note: An individual may claim up to 10 serial numbers in a program year c. Sales Price d. Select the authorized dealer Note: Dealers not eligible for the program will not appear on the claim form e. Upload a copy of the invoice 3. Additional proof will be required for the following bonus discount and personal use discount categories: a. Military and Veterans: Proof of current military or veteran status b. First Responders: Proof of current employment (e.g., employer ID) c. Educators: Proof of current employment (e.g., employer ID) d. Nurses: Proof of current employment e. Emergency Relief: Proof by news article or FEMA emergency release verifying catastrophic impact For questions, comments, or assistance, contact your local Master representative. g. Distributors and Channel Partners: Proof of employment with an affiliated distributor 4. Submit for verification and confirmation. Claims will be processed within five business days 5. Consumers will receive information on the status of the claim as it is processed and can view the status at [www.ductedsystemsincincentives.com](http://www.ductedsystemsincincentives.com) 6. Claims are paid only by check and in U.S. currency within 45 days of approval. a.
